#### Rescue and Delivery Update

As of early June, Harvest of Hope has rescued and delivered more than 90,000 pounds of food to more than 30 different agencies throughout Washington County and, sometimes, surrounding counties.

We are truly grateful to our eight regular food donors who support our food rescue mission every month: Broughton Foods, Warren's IGA, Witten's Market, Giant Eagle, Walmart, Aldi, Marietta Memorial Hospital, and Latrobe Mission. As the availability of fresh food grows throughout the coming months, several more food donors will join our efforts.

Happily, area community meal programs are beginning to serve meals once again with carry out programs. During the pandemic, Daily Bread continued its community meal program by serving about 200 carry-out meals every Wednesday.

Since the beginning of 2021, in addition to four current community meal programs, Harvest of Hope supported 12 food pantries, the Salvation Army, EVE, Washington County Home, O'Neill Center, YMCA Childcare Program, Go-Packs for Kids, Latrobe Mission, House of Hope, Marietta Bible Center, Betsy Mills Club, Washington County Juvenile Center, HAVAR, Boys and Girls Clubs, WASCO, and others.

#### 2021 Grants Update

Grants from local organizations have a significant impact:

Marietta Welfare League: \$3,000 to purchase ground beef. Harvest of Hope delivered 1,038 pounds of this meat to food pantries and community meal sites.

#### Welcome New Harvest of Hope Board Member Savannah Jeffers
